Building 1180



Left side of building 1180: Transplant existing Pygmy to marked area in front of tennis courts with 1.00 bag of red mulch. Where Pygmy palm was, install 1.00- 15 gallon Pink Powderpuff.



Left side of building below Mahogany tree: Complete removal of existing grass. Install .5 yard of top soil with 3.00- 3 gallon Red Ti and 8.00- 3 gallon sword ferns with 10.00 bags of red mulch.



Parking lot across from 1180 and 1170: WARRANTY 200 sq. ft. of sod from Proposal 259046.

No labor cost, remove and dispose existing grass below and around Oak tree. Install 1.00 yard of top soil with 18.00- 3 gallon Sword ferns, 3.00- 3 gallon Red-ti and 18 bags of Red Mulch.



Across from 1180 by parking garage: Remove existing sod, install 1.00 yard of top soil and 450 square feet of turf.

WARRANTY- Along side walk: 50 sq. ft. of sod to be installed.
