Emergency Non Emergency Supplemental Contract for Adjusting Services

The undersigned Enclave At Naples Condominium Association, Inc. (Insured) hereby retains **Reliant Public Adjusters LLC.** to be my/ our/ its agent and representative under my/ our/ its insurance contract with Zurich / Empire Indemnity Insurance Company policy # ECL9490173-04 to provide public adjusting services for the insurance claim # 5630010470 involving the property at 1295 Wildwood Lakes Blvd. Apts, FL 34104 caused by Hurricane Irma on or about 9-10-2017.

Public adjusting services provided under this agreement include inspection of the visibly damaged property, photo documentation thereof, preparation of a line-item cost estimate for the repair / replacement of the damaged property and submission of the claim to the above referenced insurance company for the payment of policy benefits, and shall include, if needed, the building/dwelling, other structures, personal property, additional living expenses and loss of use. Policyholder directs that any inspections be coordinated through our office and that all communications and correspondence be sent to our mailing address above.

In consideration for the public adjusting services being rendered, the undersigned Insured hereby assigns and agrees to pay **Reliant Public Adjusters, LLC.** 10 % of the proceeds, after deductible, recovered from this day forward, not including any previous payments made prior to the date of this Agreement, plus costs, if needed, including but not limited to the adjustment process, appraisal awards, compromise, confession of liability, judgments and settlement of damages or otherwise, as insurance benefits for said loss. Costs may include material testing, equipment rental and outside experts (e.g. appraisers, engineers, contractors, economists, accountants and forensic specialists). **Reliant Public Adjusters, LLC.** will not incur any costs without written consent and authorization from the Insured. If legal representation is needed and/or a lawsuit is filed on the claim, Reliant Public Insurance Adjuster's fees will still be due upon settlement of the claim or payment of judgment. The assignment created hereby is absolute and unconditional. The insured directs insurance company to make Insured and **Reliant Public Adjusters, LLC.** co-payees on any payments, checks or drafts issued by insurance company.

The Insured has the right to cancel this agreement within 5 business days, provided the notice of cancellation is submitted in writing and sent certified mail return receipt requested, or other form of mailing that provides proof thereof, to our mailing address as identified above. In the event a legal dispute arises relating to this agreement, the prevailing party shall be entitled to recover attorney fees and costs. This agreement shall be construed by the laws of the State of Florida. Further, the parties agree that any suit arising out of the terms of this agreement shall be brought in Palm Beach County Florida.

Pursuant to s. 817.234, Florida Statutes, any person who, with the intent to injure, defraud, or deceive an insurer or insured, prepares, presents, or causes to be presented a proof of loss or estimate of cost or repair of damaged property in support of a claim under an insurance policy knowing that the proof of loss or estimate of claim or repairs contains false, incomplete, or misleading information concerning any fact or thing material to the claim commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084, Florida Statutes.
